Tour Participant Medical History Acknowledgement: With my signed registration, I understand that Naturalist Journeys, LLC (d/b/a Caligo Ventures) has no liability for my personal medical expenses and further that I have no physical or other limiting factors that would possibly create a hazard to myself or to other participants on the tour and that the above noted responses accurately and fully reflects my personal medical information. I have been advised of the availability of insurance coverage for medical assistance and acknowledge that such insurance is my personal responsibility and my signature above is in evidence of this acknowledgement.

A) CALIGO VENTURES Deposit Schedule, Cancellations and Refunds:

- Please make payments by check or money order payable to Caligo Ventures. Please call our offer to pay by credit card.
- A deposit of \$300.00/person for group tours or Independent Birding Ventures, or \$100 for Asa Wright Lodge Stay is due with this registration and will hold your space. Please be advised that some Independent Birding Ventures outside of Trinidad and Tobago may require additional deposit based on policy of the lodges booked.
- The balance of payment is due 60 days before the departure date (Trinidad and Tobago, and continental USA departures); 90 days prior to departure (all other destinations unless noted as special terms for cruises or when noted at time of registration).
- Payment in full is required when booking less than 60 days (90 days) prior to departure as stipulated above.

B) Cancellation Policy:

- Prior to final payment at 60 days or 90 days according to stipulation stated above, \$ 100.00 of this deposit (\$25 for Lodge Stay deposit) will be non-refundable, but may be transferred to another program or other dates within one calendar year. NO REFUND will be made for lost nights or services due to flight delay or cancellation.
- Upon final payment at 60 days/90 days, the remaining amount of your deposit, and other tour fees due as outlined in the itinerary, will be refundable only as follows:
 - In full, with cancellation IN WRITING 61 days / 91 days prior to departure, subject to policies of providers requiring payment ahead of 60 days / 90 days based on destination and requirements.
 - Cancellation made 60 to 30 days prior to departure / 90 to 60 days: A charge of 30% of the tour price plus the recoverable balance exceeding this that is not refunded from providers. Depending on the tour, this may be as much as 50% or more of the tour price. Cruises or tours operated with other travel companies may be subject to special terms.
 - Cancellation within 30 days of departure: NO REFUND except as allowed for that portion under the terms and conditions of the air carrier.
 - We strongly recommend purchase of trip insurance.

PARTICIPANT RESPONSIBILITY. Though these trips are not strenuous, participants should be in good health and able to handle several hours of walking per day and adjusting to differences in altitude, time changes and other factors relating to a tour.

RESPONSIBILITY: Naturalist Journeys LLC (d/b/a Caligo Ventures) acts only as agent in obtaining transportation, including any and all forms utilized in the conduct of the tour, and other tour services. Air Carriers are not to be held responsible for any act, omission, or event during the time passengers are not aboard their aircraft. The tickets and coupons in use by such airline, when issued, shall constitute the sole contract between the airline and the tour member or purchase of these tickets. The carriers, Caligo Ventures and their employees and agents shall not be liable or directly, or indirectly held responsible for any injury or death expense, damage, delay, irregularity or other loss, whether in person or property (including with no limitation those resulting from the negligence of the companies, incurred or arising during the period of a tour or in connection with the rendering of any form of transportation or other services furnished with respect to a tour, or the failure to render such services), or in any way related to a tour. Caligo Ventures accepts no responsibility nor assumes liability for any loss, damage, accident, delay, or other irregularity caused by any reason including defect in any vehicle, or through the acts, defaults or bankruptcies of any company or person engaged in conveying the participant or providing transportation to the passenger or in the carrying out of the arrangements of the tour, or for any losses or additional expenses due to delay or changes in air schedules or other services, overbooking or sickness, weather, strikes, war, quarantine, civil disturbance or other causes. All such losses or expenses will have to be borne by the participant. Baggage, cameras, and other personal belongings are at the owner's risk throughout the tour. Tour participants recognize and accept the fact that the tour is conducted in natural areas where dangerous and venomous wild animals might be encountered over which the agent or its operators have no control or responsibility. Caligo Ventures reserves the right to alter itinerary, eliminate arrangements, or provide similar categories of substitution at no penalty; to cancel the tour prior to departure, with a full refund constituting full settlement to the participant. No refund will be made for any unused portion of the tour or for "no shows." Caligo Ventures reserves the right to refuse to accept or retain any person as a member of the tour, at any time. In this case, they will be refunded the full deposit or the amount limited to the unused portion of the tour, as the case may be. The signing of the reservation form and/or the acceptance of tour membership and/or of such coupons, exchange orders, receipts, contracts and tickets by the tour member shall be deemed to be consent to all conditions and provisos in this document. **NOTE:** All field trips and transportation described in the itineraries are conducted by independent operators. On those trips involving boats and vehicles, please be advised that such conveyances may not meet safety standards consistent with those in effect in the United States.

C) Assumption of Risk PLEASE READ AND INITIAL

I understand that there are inherent risks and dangers with the excursion, known or unknown, relating but not limited to car, truck, tractor, van, bus, train, air, kayak, canoe, raft, inflatable craft, boat, or ship travel, nature walks and hikes, backpacking, wading, swimming, snorkeling, skin diving, and scuba diving, bird watching, wildlife viewing, and photography, accidents or illnesses, and acts of nature including weather, wildlife, man or God. However, in consideration of the right to participate in this excursion, I hereby release Naturalist Journeys, LLC and their officers, agents, leaders, employers, and employees from all responsibility for damages, injuries, deaths, losses or delays due to any reason whatsoever, and I hereby assume responsibility for all risks and dangers in connection with the excursion.
